**7. Agreement Terms:**

1. Agreement: If this application is accepted, I/we agree to abide by the Constitution, ByLaws, Rules and Regulations and Berthing Policy of the Club. I further agree to promptly pay the Total Owing entered in item 6 (Membership Type), all annual dues, assessments and fees rendered by the club. I further agree that my membership will be probationary until October 2020 or for a maximum of 3 months after acceptance.

2. Mooring not Guaranteed: I understand that being a member does not entitle me to a mooring for my boat. Wet Berths are allotted in accordance with the club ByLaws to Full or Intermediate memberships based on seniority points. Dry Berths are allotted to Full, Intermediate or Junior memberships based on seniority points or to Small Craft memberships based on availability and duration of membership.

3. Volunteering: I further understand that the Oakville Yacht Squadron is a "working club" and that a Full, Full Other Harbour (FOH) or Intermediate membership must contribute a minimum of 20 hours of club-related volunteer work per calendar year or pay \$35.00 per hour for unworked hours. I pledge to fulfill my obligations as required.

**Notes:**

- OYS membership fees include the whole family (including children under 18 years of age) except Crew, Junior and Small Craft memberships which are for the individual only. Full (including FBAB) and Intermediate memberships accrue one seniority point per year. FOH memberships accrue one-half seniority point per year.
- An Intermediate Membership is valid up to age 29. At age 30 as of May 1st of the membership year, the member must convert to a Full membership to retain the accrued seniority points.
- A Crew Membership is for an individual who is part of the regular crew on the boat of a Full or Intermediate Member.
- A Junior member is between the ages of 9-21 (or up to 24 if enrolled in a full-time course of study). Junior memberships are not entitled to vote. A Junior membership accrues one-half seniority point per year to a maximum of 3 points. At age 22 as of May 1st of the membership year (or 25), a Junior membership must convert to a Full or Intermediate membership to retain the accrued seniority points.
- A Small Craft membership is for an individual who wishes to apply for a Dry Berth for a non-ballasted sailboat (dinghy), or a self-propelled craft such as a paddleboard or kayak. Small Craft memberships do not accrue seniority points and are not entitled to vote.
